DIRECTIONS: From the intersection of IN25 and US421 (Dairy Queen): Drive west on US421, shortly after the large white rooster statue on your left, turn right at the GLKC sign From Brookston/Monticello: The building is a short distance from the intersection of SR18 and US421, the building will be on your left just past the Dog House Tavern From the South: Take 65 to Exit 175 in Lafayette, turn right onto Old 25, and stay to the right to get onto the new SR25/Hoosier Heartland. The building is about 20 minutes from there. About 2 miles from the exit for Colburn, get in the left lane and turn left at the sign for Old SR25. Follow this road into Delphi; at the Dairy Queen, turn left. Our building is less than a mile from there on the right, just after the large white rooster statue on the left.
