



Spring Greetings CPE Exhibitor!

Included is information about the Tippecanoe & Rally, Too CPE agility trials on April 1-2, 2023. The building will be available for crate set up on Fri between 6:00 pm and 7:00 pm. Setup and check-in/measuring will be Sat/Sun 8:15 am (if DOS entries are being taken, this is the time to enter). The first class briefing is at 8:45 am with the first run at 9:00 am; all other

classes will follow. Handlers should take note of the class in the ring and are responsible for reporting to the Gate Steward in a timely manner. All classes will have a briefing, by the judge, and course walk through before each class.

- Carroll County ordinances require that all dogs must be on leash or be confined to crates or your vehicle when not in the ring or at the warm-up jump. You are responsible for picking up after your dog. If anyone from T&RT observes that you did not clean up after your dog, or that you let your dog run and play off-lead, you will be asked to leave the trial site for the remainder of the weekend; there will be NO refunds. There will be plastic bags available at all exit doors.

- There is only one sink available, so please bring water for your dog; we will have some jugs of water for dogs and have bottled water for workers. **Speaking of workers, we need those, too!**

- The Running Order will be posted by Thursday on the T&RT website (see below) and Course maps will be posted the night before each trial day.

- All dogs that do not have a CPE height card WILL HAVE TO BE MEASURED starting at 8:15 am; check with the Trial Secretary if your dog turned 2 yo (since last trial you entered) and needs to be remeasured. Corrections to a dog's Class, Level, or jump height (other than by the judge) will incur a fee for each class if not reported by your first run of the day. *Per CPE: Exhibitors are responsible for errors on the entry form, Level running, and posted scores - check the posting sheet and ribbon labels BEFORE leaving trial site each day!*

- There will be a full-size dark blue van parked by the Entrance door; on the other side of it will be an area for dropping off crates, chairs, etc. through the door across from the portable restrooms on the north (farthest from the road) side of the building. You can unload and then return to the south side of the building for parking and come through the main entrance. **Please DO NOT park on the north side (farthest from road) of any building.**

- There will not be food for sale on-site; but there are restaurants close by and a short drive away. We will be feeding our workers!

- Move ups will be accepted via email/snail mail until 5:00 pm on Tue, Mar 28th for the Sat trial; and move ups for Sun, for the 3 repeated classes, BEFORE leaving the trial site on Saturday.

Crating is not as spacious in this building, so be a good neighbor and consolidate.

PLEASE bring floor covering to put under your crate.

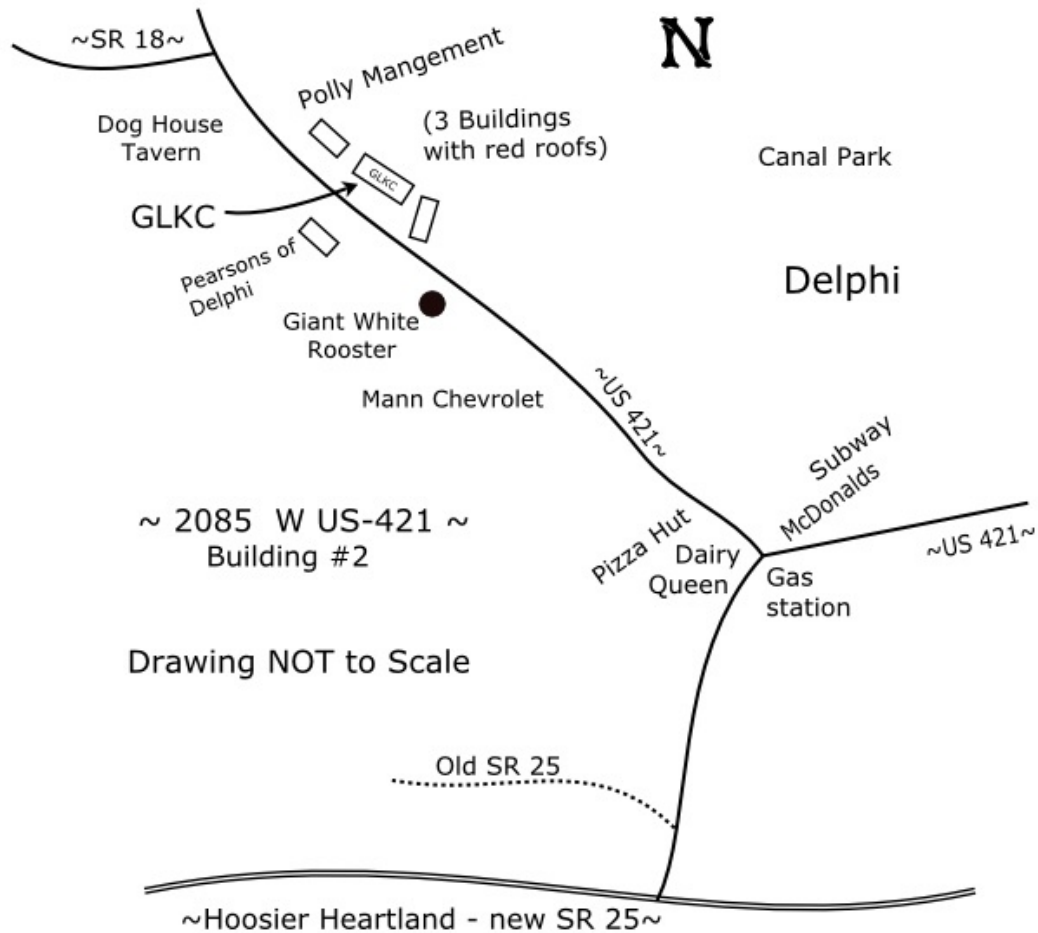

DIRECTIONS TO THE DELPHI GLKC TRAINING BUILDING

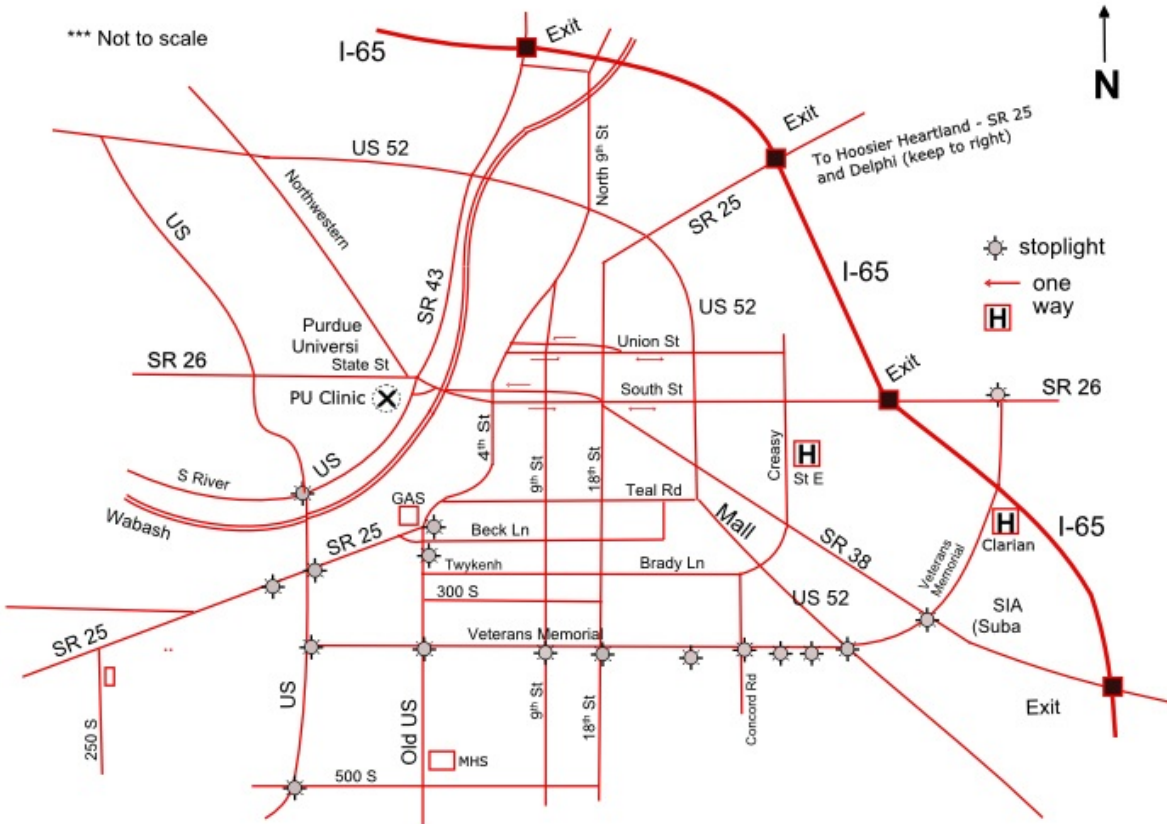
(If you want to use your GPS, then enter: Pearsons of Delphi, we are across the road.)

From the South:

The building is about 20 minutes from the intersection of Sagamore Parkway and SR 25 (and less from I-65) via the Hoosier Heartland. About 2 miles from the exit for Colburn, get in the left lane and turn left at the sign for Old SR 25. Follow this road into Delphi; at the Dairy Queen, turn left and our building is less than a mile on your right. There is a giant white rooster on the left just before our building.

From the North:

The building is a short distance from the intersection of SR 18 and US 421, the building will be on your left just past the Dog House Tavern.



Dog potty areas are around the GLKC building; plastic bags and waste buckets are available by each entrance door. County ordinance does not allow dogs to be off leash.

Motels in the area that have accepted dogs in the past, please confirm when you make reservations. PLEASE pick up after your dogs and preserve our ability to use these motels!
