

Saturday, September 25 we will offer:

Slingshot: A set course of hoops and tunnels while adding the potential for the dog to show the ability to work at a distance. (We will use jump standards in place of hoops.)

Pitstop: A numbered course made up of tunnels only.

Sunday, September 26 we will offer:

Hairpin: This is a relay race for a 2-dog team that consists of hoops and tunnels. Each dog runs the course individually and the time is the total amount of time it takes for both dogs to run the course. If you do not have a partner to run with, you may run the course twice with the same dog for practice.

Pole Position: This can be run as a solo course or as a team course. We will do the solo runs first, followed by teams. Dogs must navigate the way around barrels in the correct order and direction. (Our course will be slightly shorter than the regulation course due to poles that are on the floor.)
